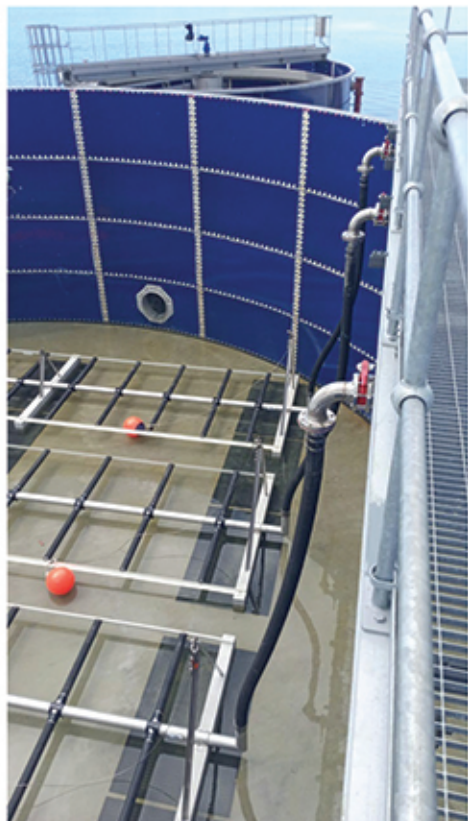

G-Water FES units are pre-designed and prefabricated for fast and easy on-site installation, while at the same time are flexible for different loading and flow requirements. All electromechanical and tankage equipment are delivered to site, reducing substantially earth movement and civil works required for its execution. Its concentric tankage design maximizes space efficiency, reducing footprint and ancillary yard piping, increasing land utilization for other needs of the client.

FES's flexible geometric design permits the simple integration of additional treatment process steps based on client's requirements, including Biological Nutrient Removal (BNR), tertiary treatment for water reuse, disinfection by chlorination or UV, among other specialized treatment needs. The **FES** is equipped with high quality components with optional advanced process control and automation equipment for ease of operation. Bolted tank technology provide unsurpassed advantages including fast and simple field-assembly, with high quality factory precision manufacturing and coating. Using synchronized jacks, installation workers stay on ground, assuring crew safety at all times. Finite Element Analysis is used to ensure a stable design base don the hydrostatic, seismic and wind loads of the applications.
